Race 1 - Quarter Horse Allowance

\$10,000

For Quarter Horses three-year-olds and upward which have never won two races or which have not won a race since December 31, 2014. Winners have preference over non-winners.

Three Year Olds 122 lbs. Older 124 lbs.

Four Hundred Forty Yards

Race 2 - OBS Sprint Stakes - Filly Division

\$50,000 Guaranteed

For three-year-old fillies that went through an OBS sales ring. Weight 120 lbs. Sustaining payments of \$100 due August 31, 2015 and \$250 due November 30, 2015; or \$500 due November 30, 2015 for three-year-old fillies that went through the 2015 OBS October Sale or for those three-year-old fillies for which the first sustaining payment was not made.

\$500 to enter and \$500 to start

Six Furlongs (Twenty Third Running)

(Supplemental nominations of \$4,000 at time of entry with \$500 to start)

Race 3 - OBS Sprint Stakes - Colt & Gelding Division

\$50,000 Guaranteed

For three-year-old colts and geldings that went through an OBS sales ring. Weight 122 lbs. Sustaining payments of \$100 due August 31, 2015 and \$250 due November 30, 2015; or \$500 due November 30, 2015 for three-year-old colts and geldings that went through the 2015 OBS October Sale or for those three-year-old colts and geldings for which the first sustaining payment was not made.

\$500 to enter and \$500 to start

Six Furlongs (Twenty Third Running)

(Supplemental nominations of \$4,000 at time of entry with \$500 to start)

Race 4 - OBS Championship Stakes - Filly Division

\$100,000 Guaranteed

For three-year-old fillies that went through an OBS sales ring. Weight 120 lbs. Sustaining payments of \$100 due August 31, 2015 and \$250 due November 30, 2015; or \$500 due November 30, 2015 for three-year-old fillies that went through the 2015 OBS October Sale or for those three-year-old fillies for which the first sustaining payment was not made.

\$1,000 to enter and \$1,000 to start.

One Mile and One-Sixteenth (Twenty Seventh Running)

(Supplemental nominations of \$7,500 at time of entry with \$1,000 to start.)

Race 5 - OBS Championship Stakes - Colt & Gelding Division

\$100,000 Guaranteed

For three-year-old colts and geldings that went through an OBS sales ring. Weight 122 lbs. Sustaining payments of \$100 due August 31, 2015 and \$250 due November 30, 2015; or \$500 due November 30, 2015 for three-year-old colts and geldings that went through the 2015 OBS October Sale or for those three-year-old colts and geldings for which the first sustaining payment was not made.

\$1,000 to enter and \$1,000 to start.

One Mile and One-Sixteenth (Twenty Seventh Running)

(Supplemental nominations of \$7,500 at time of entry with \$1,000 to start.)

Thoroughbred races will be limited to fourteen (14) starters. Preference given to those with the highest total earnings. Entry fee to be returned to excluded entrants.

Substitute Race 1 - Quarter Horse Starter Allowance

\$10,000

For Quarter Horses three-year-olds and upward which have started for a claiming price of \$10,000 or less in 2015 or 2016. Winners have preference over non-winners.

Three Year Olds 122 lbs. Older 124 lbs.

Two Hundred Twenty Yards

The Quarter Horse race will be limited to ten (10) starters with four (4) also eligibles. Winners receive first preference over non-winners. Second preference will be given to those with the highest lifetime earnings.

If the Quarter Horse race overfills and multiple horses are entered that are owned wholly or in part by the same owner, and both horses would draw in based on the preference rule stated above, the trainer(s) shall designate which horse is preferred and the other horse will receive the least preference.

All horses will race as separate wagering interests.

The races will be conducted according to Florida Statutes Chapter 550 as administered by the Division of Pari-Mutuel Wagering of the Department of Business and Professional Regulation. It is understood and agreed that the entries are accepted with the understanding that the horse so entered will only be allowed to start if in good standing at the time of the actual running of this event.

- **STABLING** - All horses must be stabled in the receiving barn at least four hours prior to first race post time.
- **LICENSING** - All owners, trainers, and racing personnel must be licensed and their fingerprints on file with the Florida Division of Pari-Mutuel Wagering. Only licensed personnel will be allowed in the receiving barn and restricted areas. PLEASE DISPLAY THE FLORIDA RACING LICENSE AT ALL TIMES WHILE IN RESTRICTED AREA (A TRACK BADGE IS NOT ACCEPTABLE).
- **WORKERS' COMPENSATION INSURANCE** – A current policy must be on file with OBS prior to shipping on the grounds indicating Florida coverage and including OBS as a certificate holder. Contact Harriet Booth at OBS office for assistance.
- **JOCKEY CLUB or AQHA Registration Certificates** must be on file with OBS in order to race.
- **TATTOO** - All horses must be lip tattooed
- **COGGINS** – a negative Coggins Test dated within one year of race day must be on file at the OBS office.
- **HEALTH CERTIFICATE** – A Certificate of Veterinary Inspection dated within seventy two (72) hours of arrival must accompany any horse when shipped onto the OBS grounds and include the following statement:
 - “The horses listed on this Certificate of Veterinary Inspection have not originated from, nor been stabled on, premises which has had Herpes Virus Type 1 (EHV-1) diagnosed during the previous thirty (30) day period.”
- **THE FOLLOWING FORMS ARE AVAILABLE ONLINE AT OBSSALES.COM AND THE OBS OFFICE:**
 - **EHV-1** vaccination record (dated between 14 and 120 days from date of the race) must be submitted to OBS or stated on the health certificate.
 - **FUROSEMIDE (SALIX)** – A horse on Florida’s official Salix List must be administered Salix no later than four (4) hours prior to scheduled post time by a Florida Division of Pari-Mutuel Wagering licensed veterinarian. Salix forms, tags and notice of First Time use must be on file at the Racing Secretary’s office.
 - **MEDICATION** – Permitted medications for horses are to be administered according to Florida Rule 61D-6.008.
 - **W-9 FORMS** – Owners and Jockeys must complete W-9 Forms prior to receiving payment from OBS.
- **HORSESHOES** - A horse may not train or race with front shoes that have toe grabs which exceed 2mm, or bends, turn-downs, stickers, jar caulks or any other traction device. Turn-downs of more than ¼” will not be permitted on hind shoes. OBS recommends the use of only flat Queen’s Plate, Queen’s Plate XT or equivalent on the Safetrack surface.
- **SAFETY VESTS AND HELMETS** - OBS requires **ALL** riders to wear an approved safety vest and helmet while on horseback. This applies to anyone aboard any horse (Ponies included). Safety vests must be zipped and helmet straps fastened at all times including to and from the racetrack and in the shed row.
- **PROHIBITED PRACTICES ON OBS GROUNDS:**
 - Extracorporeal Shock Wave Therapy or Radial Pulse Wave Therapy
 - Acupuncture and/or Electro-Stimulation with the intent of altering laryngeal function
 - Electrical devices designed or used to increase the speed of a horse
- **JOCKEYS** - All Jockeys must have ridden in one (1) or more Official Races during the seven (7) days prior to the races, or in five (5) or more Official Races in the sixty (60) days prior to the races, or in fifty (50) or more Official Races in the twelve (12) months prior to the races, or is an apprentice jockey or foreign jockey riding in his or her first race.
- **TRACK HOURS** are from 6:30 AM until 11:00 AM except 9:00 AM on Monday January 25th due to the Under Tack Show.
- **DOGS** are not allowed on the grounds.
- **PURSES** will not be distributed until OBS receives blood and urine sample test results. OBS will withhold payment of purses to any owner for any horse which has suspicious or positive test results.
